

BEST PRACTICES

- Clearly write your ticket number on a Dry Erase Board for the yard clerk to see. (Please contact customer service if you need a dry erase board.)
- Use bungee cords, zip ties, tape etc. on chassis pins. Feel free to utilize the free taping stations as seen on the terminal map.
- Please apply air brakes when under the canopy.
- If you believe you have a roadability concern, ensure you are using the Broening Hwy Outbound Gate. — Please follow the instructions of the outbound Roadability mechanics.
- Ensure you have received a completed interchange text message before exiting the terminal.
- Be aware that in-house yard trucks may be traveling against the flow of OTR traffic. This DOES NOT mean you may also travel against the terminal traffic pattern.
- If you are presented with a problem or are unsure what to do, contact customer service and they will guide you.
- Utilize the ‘Flip Area’ when you are given a container that is not sitting properly on your chassis. The Flip Area, represented by a 20’ orange container, will be somewhere on the berth. — There are times that we will be unable to properly sit your container due to unforeseen damage. In many cases, depending on severity, you will have to cancel your ticket.
- Be aware of RTG crossings. Container handling equipment has the right of away at intersections.

OTR RULES

- **Unlock and secure pins/cargo:** Do so at the inbound canopy during your initial inspection and lock your pins in the designated out of the truck areas prior to leaving the terminal. If your pins become locked in the yard please return to the designated out of truck areas in order to reposition them before returning to the yard.
- **Stay in your truck:** Do not exit your truck when in the container yard. There are designated out of truck areas as seen on the map.
- **Obey terminal signage:** This includes stop signs, intersections, speed limits and traffic routing signage.
- **Do not block intersections.**
- **Please follow terminal traffic pattern:** The traffic flow for OTR drivers is represented on the attached map. Note that it represents a one-way traffic pattern.
- **Do not travel through the container stacks:** There is no tolerance for a driver traversing through a container stack to access another row. If you are in the wrong row follow the proper traffic pattern to get to your row.
- **Safety vests are required:** Once you have entered Seagirt an ANSI certified safety vest must be worn at all times.
- **Lining up your truck for delivery:**
 - Top Loader: When dropping off, line your container up against the pile at the drop off location you were given. Those numbered locations are painted on the ground. When picking up, stop your chassis one stack ahead of your given location. After picking up your container, the top loader operator will direct you to pull forward /stop with one beep and reverse with two beeps.
 - RTG: Line your chassis against the pile you were given. Those numbered locations are painted on the ground. The RTG operator will signal you as needed with one beep to pull forward /stop and two beeps to reverse. An all clear beep will sound for you to pull away after the RTG spreader detaches.
- **Stay off the RTG tracks:** Ensure that you are staying a safe distance from the RTG runway avoiding RTG ladders.
- **No speeding:** The Terminal Speed limit is 20mph.
- **Keep it moving:** Do not loiter in the designated out of truck areas.
